

Vacuum System Diagram




Operating Instructions

- 1. Place unit at side of pool.
- 2. Make sure ON/OFF switch is set on OFF.
- 3. Make sure GFCI is reset.
- 4. Plug unit into 20 amp GFCI outlet
- 5. Attach discharge hose to outlet side of filter and make sure the union barb is tight with original O-ring in place and place discharge hose into pool.
- 6. Open bleeder valve at top of filter to purge air from tank.
- 7. Fill hair and lint trap with water and retighten lid.
- 8. Flood the suction hose by holding completely under water, then place hand over suction hose to keep water in the hose while attaching to the side union barb (make sure union barb is tight with original O-ring in place). May use optional union check valve.
- 9. Start unit by turning the ON/OFF switch to ON position.
- 10. Once unit starts to prime watch air relief valve on top of filter. When water comes out of the air relief valve all air has been purged from the filter. Retighten air relief valve and allow a 1 -2 minutes for the pump to prime.
- 11. Vacuum as needed.
- 12. If unit does not prime redo steps 1-9.
- 13. Turn off all power and disconnect the unit from the power source before any service is performed.
- 14. Any questions may be answered by calling the Technician live at 1-800-636-8866.
- *When using standard flex vacuum hose it is advisable to remove the white plastic cuff from the vacuum hose. The cuffs are designed to be used in a skimmer, under water, and will draw in air on the suction side causing priming issues and loss of water flow to the vacuum system.

Pump Assembly Diagram





MOTOR WILL NOT START

- 1. Check Circuit Breakers
- 2. Check for incorrect or loose wire connections.
- 3. Make sure the correct power supply is being used.
- 4. Any on/off switch or pneumatic switch should be in the "on" mode.

MOTOR OVERHEATING AND CYCLING ON AND OFF

- 1. Check for incorrect or loose wire connections.
- 2. Check for low voltage supply (frequently caused by undersized wire).
- 3. Make sure the motor gets a fresh air supply and the vents are kept unclogged.

MOTOR MAKES HUMMING NOISE BUT WILL NOT START

- 1. Make sure motor shaft turns free.
- 2. Check for jammed impeller or an obstruction in casing.
- 3. Check for low voltage and undersized wire.

PUMP WILL NOT PRIME

- 1. Make sure pump is installed at the proper level and the plumbing lines have been correctly installed to allow the water to enter pump freely.
- 2. Open air control valves to release any possible air lock.
- 3. Make sure all suction and discharge lines are clear and unobstructed and all valves are opened.
- 4. Check for air leaks in the suction line.
- 5. Remove white cuff from flex hose.

LOW WATER FLOW

- 1. Check filter pressure gauge, filter may need cleaning.
- 2. Check for clogged plumbing lines.
- 3. Check for worn or damaged impeller.
- 4. Check for low voltage.

WATER LEAKS

- 1. Check contamination or damage to shaft rotary seal. Replace if necessary.
- 2. Check compression fitting (union connectors), make sure they are properly aligned and secured. Hand tighten only.Do not use tools.
- 3. Make sure the O-ring is properly sealed and not damaged.

NOISES

- 1. Check plumbing vibration make sure lines are adequately supported.
- 2. Check for cavitation, due to obstruction in or undersized suction line.

CLAIMS: All Freight Damage claims must be made within ten (10) calendar days after receipt of the merchandise. If any shipment is received in a damaged condition, your claim must be filed with the delivering carrier and noted on the freight bill before you accept the merchandise.

RETURNS: All returns are subject to our written approval and must be accompanied by a "Return Goods Authorization" number obtained from Advantage Manufacturing (ADM) prior to shipment. Unauthorized returns will not be accepted. Freight must be prepaid. Material returned for credit, if in original condition and resaleable, is subject to a 20% handling charge.

TAXES: Any Federal or State Excise or Sales Tax for which ADM may be liable on any sale will be charged to and paid by the buyer. Buyer is responsible for furnishing a resale certificate.

PRICES: Prices and Products are subject to change without notice.

LIMITED WARRANTY: To Buyer, as original purchaser of the Goods, ADM warrants its products free from defects in materials and workmanship for a period of one year from the date of purchase. Parts which fail or become defective during the warranty period, except as a result of freezing, negligence, improper installation, use or care, shall be repaired or replaced, at our option, within ninety (90) calendar days of the receipt of the defective product, barring unforeseen delays. To obtain warranty, replacements or repair, defective components or parts should be returned, transportation paid, to the place of purchase. No returns may be made directly to the factory without the express written authorization of ADM. Pump housing/strainers which become defective during the warranty period, except as a result of freezing, negligence, improper installation, use or care, or as the result of use in association with an automatic valving system, shall be repaired or replaced, at ADM's option, without charge. All other conditions and terms of the standard warranty apply. ADM shall not be responsible for cartage, removal and/or reinstallation labor or any other cost incurred in obtaining warranty replacements. The foregoing warranty does not apply to components manufactured by others. For such products, the warranty established by the respective manufacturers will apply. Shaft Seal failure not covered under warranty.

LIMITATION ON IMPLIED WARRANTIES: Implied warranties, including any warranty or merchantability imposed on the sale of the goods under state law, are limited to one year duration for the goods or any parts.

LIMITATIONS OF LIABILITY: THE ESSENTIAL PURPOSE OF THIS PROVISION IS TO LIMIT ADM'S LIABILITY HEREUNDER. ADM and buyer agree that any action or proceeding arising out of or in connection with any sale of product or service, will be brought exclusively to a court of competent jurisdiction in the County of Orange, State of California.
